The Institute for Stem Cell Science & Regenerative Medicine (www.instem.res.in), Bangalore is an autonomous institute of the Department of Biotechnology, Government of India. inStem's mandate is to establish collaborative research programs in the field of stem cell biology, regeneration and repair in development and disease and with translational emphasis. In order to develop strengths in focused areas, research at inStem is programmatic, driven through collaborative inter-disciplinary themes, addressing questions, which are beyond the scope of a single laboratory. InStem shares a campus and research facilities with the National Centre for Biological Sciences (NCBS-TIFR) and the Centre for Cellular and Molecular Platforms (CCAMP).
