In particular, applicants interested in developing and/or applying cutting edge technologies to gain insight into fundamental aspects of stem cell biology and translation towards regenerative medicine. inStem Investigators are expected to apply for grant funding but in the first instance, start-up support is provided. About the Posts: The Institute for Stem Cell Science & Regenerative Medicine (www.instem.res.in), Bangalore is an autonomous institute of the Department of Biotechnology, Government of India. inStem's mandate is to establish collaborative research programs in the field of stem cell biology, regeneration and repair in development and disease and with translational emphasis. In order to develop strengths in focused areas, research at inStem is programmatic, driven through collaborative inter-disciplinary themes, addressing questions, which are beyond the scope of a single laboratory. inStem shares a campus and research facilities with the National Centre for Biological Sciences (NCBS-TIFR) and the Centre for Cellular and Molecular Platforms (CCAMP).

Applications must include a CV and a well-articulated research plan that closely aligns and synergizes with ongoing research in the following themes: Brain Development and Disease Mechanisms (BDDM) and Center for Cardiovascular Biology and Disease (CCBD). The BDDM seeks to understand the development of the mammalian brain at multiple scales of organization from molecules to brain circuits and behavior. The cardiovascular biology theme is engaged in mapping structural, cell-biological and genetic basis of cardiovascular biology using stem cells, animal models and human genetics. Candidates should be interested in exploring cellular, inter-cellular/tissue and physiological connections of these systems. Outstanding applications that bridge themes at inStem in addition to these two will also be considered, but all other requirements apply. Thus, research programs that span more than one theme will be considered. However, the integration, if spanning more than one theme, must be clearly explained and justified.

Compensation / Pay Details: The post carries the Pay Levels as mentioned against each in the pay structure of 7th CPC Pay Matrix (Entry Level) and other benefits which include Dearness Allowance, House Rent Allowance (in lieu of accommodation), Transport Allowance, Children Education Allowance, Leave Travel Concession, Medical Facilities as per Govt. of India Rules. To apply for the position, interested candidates may log into inStem website – Careers-- Faculty positions (<https://www.instem.res.in/faculty-positions>).

A complete application will include a well-articulated research program plan that closely aligns and synergises with ongoing research in the themes, accompanied by a CV, names of eight professional referees as well as a cover letter clearly outlining their research accomplishments and the intersections of their future research with a theme. Incomplete applications, missing any of these sections will not be considered. Applicants are encouraged to engage with theme coordinators for the articulation of their research plans, however these discussions will not influence the process of selection and shortlisting process. Alignment and integration of the applicant’s research program with the overall trajectory of a theme is a key criterion for shortlisting. Interdisciplinary and collaborative research is strongly encouraged. inStem Investigators are expected to apply for grant funding but in the first instance, initial support is provided.

The applicant needs to fill the online application form and upload the following on the application portal:

- A complete curriculum vitae.
- A well-articulated research plan that must closely align and synergizes with ongoing research in any one (at most two) of the themes.
- A cover letter articulating synergies with the selected theme[s] and indicating the position and advertisement number.
