Selection process: The Selection process shall involve a Written Test and Skill Tests. Those shortlisted in the written test only will be called to attend the Skill Tests. Those who qualify in the Written Test and Skill tests will be selected as per merit.

General Conditions:

- 1. Incomplete applications shall be summarily rejected and no correspondence in this regard shall be entertained.
- 2. Candidates must ensure that he/she fulfils the eligibility criteria as stipulated in the advertisement.
- 3. All eligibility conditions will be determined with reference to the crucial date of eligibility i.e., the closing date of receipt of applications.
- 4. Candidates are advised to keep a printout of the application form.
- 5. This is purely a temporary engagement under the Gates Foundation Project, and selection does not entitle a candidate to any claim whatsoever of permanency or regularization against any regular post or any vacancy arising in the future in this or any other cadre/post on the basis of this service in the institute.
- 6. The incumbent may be assigned any duty during his/her tenure under the project and may be posted in different sections according to project requirements.
- 7. No claim for any service benefits like PF, Pension, Gratuity, Medical Allowance, Seniority & Promotion, etc. is applicable to these posts.
- 8. The appointment will be on a full-time basis and he/she will not be permitted to take up any other assignment during the period of contract. The contract may be terminated by either party by giving one-month advance notice in writing.
- 9. The incumbent will be required to conform to the rules and regulations of inStem in force from time to time and follow the discipline rules of the institute failing which the contract may be withdrawn at any time
