<b>Selection Process</b>	The recruitment process for the Administrative Officer (Deputation) will be completed through an interview.
<b>Call Letter</b>	Call letters to the provisionally shortlisted candidates will only be sent to their e-mail IDs as mentioned in the application.

<b>Traveling Allowance/Stay</b>	No TA/DA will be paid for appearing in the interview. Candidates have to make their own arrangements for stay/food etc.
<b>NOC from the current employer and copy of APARs</b>	Provisionally shortlisted candidates must bring a ' <b>No Objection Certificate</b> ' from their current employer with copies of APARs of the last five years, duly stamped and sealed (where applicable) as per the instructions mentioned in the advertisement.
