1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. Only OEM or OEM-authorized distributors are eligible to participate in the tender.
- 2. The OEM-authorized distributor need to provide appropriate authorization certificates as part of th eir support.
- 3. The service provider should ensure that 24/7 support should be made available throughout the contract period.
- 4. The spares and consumables must be promptly provided in case of machine/system failure during the contract period.
- 5. The Bidder/Tenderer/Participant should have an office in Bangalore or at least in the consignee's s tate for streamlined support services.
- 6. The period of contract shall be initially for one year from 01.04.2024 to 31.03.2 025 and may be extended for another year subject to the satisfactory perform ance.
