Fabrication of Customized SS 316 TV Stand

- 1. The material of construction should be SS 316
- 2. The thickness of the seamless tube should be 4 mm
- 3. The SS 316 seamless tube diameter should be 50mm
- 4. The height of the SS 316 tube should be 60" inches Quantity 2
- 5. The SS 316 flange with 4 number of holes to be grouted in the ground with appropriate bolt/nuts Quantity 2 nos
