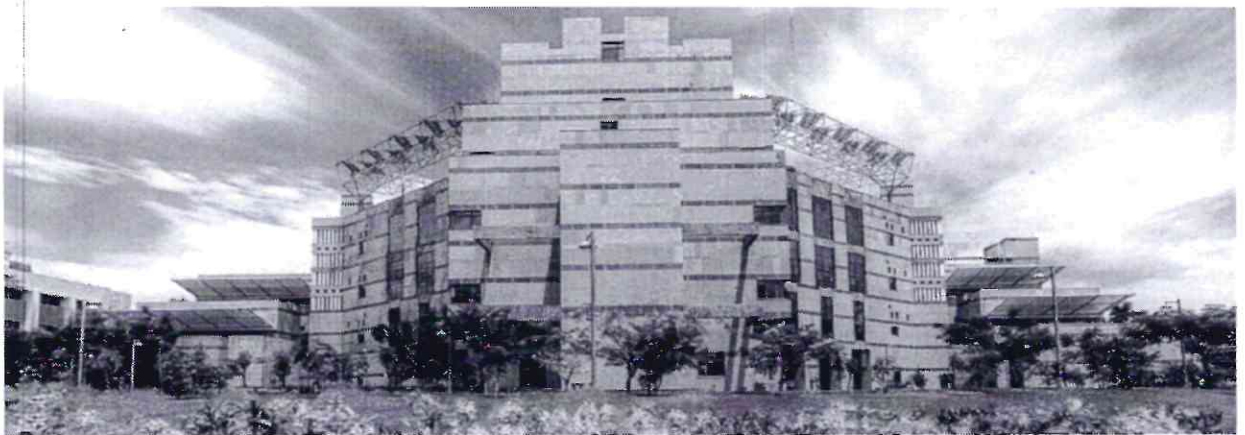

SPECIFICATION & SPECIAL CONDITIONS OF CONTRACT

1. Unless otherwise specified, the work shall be carried out in accordance with the CPWD technical specification 2009 which can be downloaded from the following link <https://cpwd.gov.in/Publication/Specs2019V1.pdf>
2. In the event of any dispute with the specifications, the following shall be the order of priority to decide the issue: -
 - a. Specifications in the Schedule of quantity.
 - b. CPWD specifications
 - c. ISI specifications
 - d. Instructions of Engineer in charge.
3. Before quoting the contractor shall inspect the site of work and shall fully acquaint himself about the conditions with regard to accessibility of site required for the satisfactory execution of work. No claim whatsoever shall be entertained by the department on this account.
4. The quantities shown in the schedule are tentative and may change as per site conditions. The Contractor shall not claim anything extra on this account. The payment shall be made as per actual quantities of work done and as per the conditions of the contract.
5. The work executed under the contract shall be subject to inspection carried out by the departmental officers. Any defects regarding workmanship or quality of material to be used as pointed out during or after completion of work by the departmental officers shall have to be rectified by the contractor and in case the contractor fails to do so, it will be got rectified by the department at the risk and cost of the Contractor.
6. All precautionary measures should be adopted for the safety purposes for any accident during the execution of work occurring at site, the contractor shall be overall responsible for the same.
7. After the award of work, if the agency fails to start the work, the agency will be debarred for a period of three years to quote tender/quotation for inStem works.
8. The contractor shall submit GST, PAN and Experience Certificate of firm.
9. Similar work means ***Having experience in Civil works like earthwork.***
10. The Contractor shall clean the site after completion of work in all. Any dismantled material shall bestacked in designated place as instructed by the Engineer-in-charge.

11. Bid Securing Declaration form: Quotations received without the Bid Securing Declaration form will not be considered. No request for exemption in submitting the bid declaration form will be considered.
12. **Security Deposit** shall be deducted @ 2.5 % from each bill of the Contractor and shall be released after the completion of defect liability period i.e. 06 months after the date of completion.
13. Taxes shall be deducted from the bill as per GOI rules for which the Contractor will submit a PAN, in the name of registered company proprietor for depositing TDS.
14. No advance payment will be made.
15. The deviation limit for the work shall be $\pm 10\%$.
16. No T & P shall be supplied by the inStem.
17. All materials brought at site shall be got approved from the Engineer-in-charge before being used.
18. The contractor should sign & stamp all pages of the quotation.
19. **Measurements:** The earth work will be measured in cubic content to the nearest two decimals in cubic meters. The measurement of the vehicle trailer will be taken after the loading and a reduction of 8% towards void will be reduced from the quantity of each trailer.
20. **General Conditions of Contract:** General conditions of the Contract-2020 (for maintenance works) will be applicable https://cpwd.gov.in/Publication/GCC_Maintenance_Works_2020.pdf and in the case of any discrepancies, following order of priority will prevail :
 - a. Special conditions of contract
 - b. General conditions of contract
21. **Rate :** The rate quoted shall be inclusive of all taxes (except GST which shall be quoted separately), levies, 1% cess towards BOCW and any other cess etc. and for complete scope of the work and as such no extra shall be applicable.
